To our Parish Pastors, Church Council Members, Treasurers:

For year-end synod gift encouragement we have provided each parish with envelopes. Please consider utilizing the envelopes provided to your parish (should arrive by Nov. 30th). Please include these envelopes in your Sunday bulletins one of the first three Sundays in December (December 2, 9, 16). A cover letter with a sample announcement is provided with your box of envelopes. A reminder letter will be sent via email. | Year-end note to Church Treasurers: Please note that our administrator, Mr. Keith Wiederhoeft, requests that you send your church offerings for synod by January 7th. If your treasurer uses the electronic option, that date extends to January 9th. Call him if you have questions (507-344-7395).

Year-end Christian giving and tax planning is always a good stewardship exercise.

Consider...

1. **Making sure you are on track** with your proposed yearly giving to your church and missions (proportional, generous).
2. **Maximizing your gift deduction by using one or more of the following strategies.**
 - a. **“Bunch” your gifts** and make sure you can itemize and take your full deduction.
 - b. **Consider other ways to give**, such as gifts of appreciated assets allowing you to receive a full deduction for value.
 - c. **If you are age 70 1/2 or older** note that the IRA rollover may return for 2012-2013 tax years. Stay tuned for the news.
 - d. **Partial tax-free income** from a Charitable Gift Annuity may be a good GREAT strategy for you and your spouse, especially if you are already planning to make a gift. Much of your income from charitable gift annuities becomes tax-free income.

Dear Fellow Workers in Christ’s Kingdom:

Advent has us contemplate for ourselves the “three-fold coming” of our Lord Jesus – his incarnation, his coming again in glory, and his work in our hearts through the means of grace. Linked with the latter, we wish to share a remark by our seminary president in his Lord’s Supper devotional. He writes of the significance of the term “Maranatha” (O Lord, come), how it brings to mind for us the immeasurable value of the Lord’s Supper:

Maranatha in the liturgy of the ancient church not only reminded the faithful of the Lord’s coming in Bethlehem but also of his coming in the Holy Supper. As certainly as the child came to Mary that first holy night, so he comes to us with his body and blood in the Sacrament. At the altar the Christmas miracle, the mystery of the incarnation, is made perfect for us, a great and mighty wonder. Here we receive his body and blood for the complete forgiveness of our sins. The Sacrament gives us comfort in this life and hope for the life to come. The Father gives us his Son under the form of bread and wine as a foretaste of the wedding feast of the Lamb, which will be ours at the final coming.


Lingenfelder Colloquy
